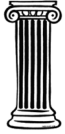

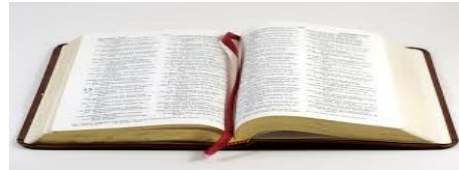

**By-Laws and Constitution Regarding Board Membership
ARTICLE 9 OFFICERS**

EXECUTIVE OFFICERS COMMITTEE

The Executive Officers Committee of the corporation shall consist of the Chief Executive Officer, the Assistant Chief Executive Officer for Ministry Services and the Assistant Chief Executive Officer for International Ministry Services and such officer or officers as may be added from time to time by action of General Conference.

GENERAL EXECUTIVE BOARD

The General Executive Board shall consist of the Executive Officers Committee, the duly elected director of each region, and three additional credential holders (members at large)

TERM OF OFFICE

EXECUTIVE OFFICERS COMMITTEE

The term of office for members of the Executive Officers Committee shall ***be four years and incumbents may be elected to further terms of office***. The Chief Executive Officer shall be elected at the annual General Conference from the election of the other members of the Executive Officers Committee. The term of office shall commence by policy of the General Executive Board.

Note that according to the By-Laws and Constitution of Pillar of Fire Churches International only those members who are ordained will qualify for nomination. Appointments may also be made by the General Executive Board for Treasurer, Secretary and any other officer that may be required. (see By-law 3)
