



OUR CONSTITUTION and MARRIAGE CEREMONIES

Members are encouraged to acquaint themselves with their Licensed Minister's and Ordained Minister's manual.

For Ordained Minister's there are requirements relating to the performing of marriages. Members are advised that our constitution specifically permits only the union of one man and one woman with respect to the marriage ceremony. There are also certain clauses that must be included in the ceremony according to provincial legislation.

If these clauses are not included in the ceremony, the marriage could be ruled as invalid and the clergy performing the ceremony could have their license revoked by the **R**egistrar.

This is also covered in more detail on page 4.

THE FEDERAL MARRIAGE ACT AND THE CHRISTIAN ORDAINED MINISTER

FEDERAL STATUTE - GOVERN MARRIAGE

As a Pillar of Fire member and ordained ministers authorized to perform marriages, this information is in respect to the legal requirements when performing marriage ceremonies in Canada, particularly with respect to marriages that are in conflict with and outside of the Biblical teaching of what constitutes a marriage covenant in the eyes of our God.

The legislation, which regulates marriages in Canada dealing with this matter, is a Federal statute and therefore is regulated under federal law. The Civil Marriage Act reads as follows:

The <u>Civil Marriage Act, SC 2005, c 33</u> was enacted in 2005 to authorize marriage between two persons who are other than a man and a woman. Section 2 reads: "Marriage, for civil purposes, is the lawful union of two persons to the exclusion of all others." Accordingly, gender is not specified in Canadian marriage legislation. However, as noted below in Section 3 and Section 3.1 religious officiants (ordained clergy) are free to refuse to perform marriages that are not in accordance with their religious beliefs (See section 3 and 3.1 below).

3 It is recognized that officials of religious groups are free to refuse to perform marriages that are not in accordance with their religious beliefs.

3.1 For greater certainty, no person or organization shall be deprived of any benefit, or be subject to any obligation or sanction, under any law of the Parliament of Canada solely by reason of their exercise, in respect of marriage between persons of the same sex, of the freedom of conscience and religion guaranteed under the *Canadian Charter of Rights and Freedoms* or the expression of their beliefs in respect of marriage as the union of a man and woman to the exclusion of all others based on that guaranteed freedom.

In our Minister's Manual we describe this as well and also the requirements for wedding ceremonies and what is to be included in that ceremony as required under provincial laws.
